Please pay additional attention to the following items that are commonly overlooked.

Section 1: Federal Employer's ID Number or Social Security Number; whichever number coincides with your Federal Income Tax Filing.

Section 2: Type of Business – you must complete this section. If your company is anything other than a sole proprietorship (i.e., corporation, partnership, limited liability company, etc.), YOU MUST ATTACH a copy of the company's articles evidencing formation, organization or incorporation. A sole proprietorship has only one owner, who is also an Alabama licensed auctioneer.

Section 4: The Board encourages you to read its Rules and Regulations before completing this section, especially Rule 150-X-1-.02 – Application for Auctioneer's License.

For corporate entities other than sole proprietorships, the principal auctioneer must be an Alabama licensed auctioneer and be a part owner/member of the company and/or have an office/position within the company. As proof thereof, YOU MUST ATTACH a copy of the company's official meeting minutes, resolution or other official action evidencing the principal auctioneer's election to the corporate office or the auctioneer's stated position in the company. All such corporate minutes or resolutions or must be executed on behalf of the company by the appropriate corporate officers; any legal agreement between the company and the principal auctioneer must be signed by the auctioneer and all corporate owners. Alabama law also requires that you provide proof of citizenship for the licensed principal auctioneer and ALL non-auctioneer company owners.

**Please be advised that the Board office cannot provide legal advice regarding the formation of an auction company. If you require assistance, you are advised to consult an attorney or certified public accountant.**

**Page 4 Escrow Account Form** – An escrow account must be established for your auction company. The company may create such an account in its own name or utilize the principal auctioneer's escrow account. In lieu of an escrow account, the company may establish a regular checking account that will be used solely for handling all monies received at auction and disbursed to sellers. This account may not be utilized to pay the company's everyday expenses, such as utilities, cleaning services, or food purchases. If for some reason your company won't be handling funds, please provide a written explanation therefor and submit it with your application.

RE: Licensing of Companies Engaging in the Auction Business

Dear Licensee:

This letter is to inform you that effective October 1, 2011, pursuant to the provisions of ALA. ADMIN. CODE r. 150-X-1-.02 and ALA. CODE §§ 34-4-20 and -28 (1975 as amended), companies engaging in the auction business in the State of Alabama will be required to obtain a license from the Alabama State Board of Auctioneers and to maintain that license through annual renewals.

The licensure requirement applies to any legal entity which engages in the business of auctioneering, as defined by the Auctioneers License Act and the Board's rules. An auction company exclusively owned and operated by an auctioneer licensed by this Board and in good standing therewith will be exempt from the requirement for a separate auctioneer license; however, auctioneers fitting within this exemption must still complete and file an auction company application with the Board; however, the license fee does not apply. If your auction company is not exempt, then you must submit the application and licensure fee of \$200.00.

**An individual designated as the principal auctioneer in the application and named in the license must be a licensed auctioneer in good standing with the Board and must be an officer of said auction company. Apprentice auctioneers are ineligible to satisfy these requirements.**

Auction companies operating without a license after October 1, 2011, may be considered to be in violation of ALA. CODE §34-4-20 (1975 amended) and subject to the applicable penalties and provisions of the Auctioneers License Act.

Enclosed you will find an application for an auction company license. Please complete the application and submit it along with the application/license fee of \$200.00 (in applicable) to your company.

3. I understand that if I am an Apprentice Auctioneer, I do not qualify to serve as the Company's Principal Auctioneer, even if I am the Company's owner. Only a duly licensed Auctioneer may serve as the Principal Auctioneer for an auction company.

I understand that if I am the sole owner and operator of the Company and a licensed Auctioneer in the state of Alabama, I am exempt from the requirement to obtain a separate auction company license, but I must still submit a completed auction company application form to the Alabama State Board of Auctioneers for its records. I do not have to submit an application or licensure fee for the auction company license if I am the sole owner and operator of the Company and a duly licensed Auctioneer in the state of Alabama.
5. I understand that the Principal Auctioneer is responsible for all the auction activities conducted on behalf of the Company. I understand that the Company may also have other officers and/or employees who are licensed Auctioneers and conduct auction business on behalf of the Company. I understand and acknowledge that only Auctioneers licensed in the state of Alabama may conduct auction business in Alabama on behalf of the Company.
6. I understand that only a licensed Auctioneer may offer, negotiate, or attempt to negotiate a contract for the sale of any goods or property, including real property, by means of public auction on behalf of the Company. I understand that it is a violation of Alabama law if an Auctioneer fails to enter into a written contract with the owner or consignee of any property to be sold at public auction containing the terms and conditions on which the Auctioneer received the property for sale.
7. I understand that only a licensed Auctioneer may cry bids for any public auction held by the Company. I understand that once the Company obtains its auction company license, it may contract with other licensed Auctioneers to cry bids for the Company.
8. I understand that any Company advertisement for an auction sale must clearly and conspicuously identify the Principal Auctioneer's name and state license number, together with the name and state license number of any other Auctioneer responsible for the auction. In addition, Internet advertisements for specific auctions with online-bidding must also list the name and state license number of the Company's Principal Auctioneer.
9. I acknowledge and understand that any and all funds received from auction sales by the Company must be maintained in the Company's or the Principal Auctioneer's escrow account, as applicable.
