YOUR AUCTIONEER LICENSE IS DUE FOR RENEWAL



The Board highly encourages you to renew online for the health safety of all. NO COMPANY LICENSE CAN BE RENEWED ONLINE! The Board will mail you a renewal form or you may download one from the RENEWAL SEASON section of the website and submit it via mail, along with the designated fee. The Board highly encourages you to keep up with new laws, rules and regulations, as well as policy changes by going to its website. The Board continues to move forward with going to a paperless process, including all applications, renewals, etc. and wishes to make this transition as smooth as possible.

# RENEWAL INSTRUCTIONS

Visit **www.auctioneer.alabama.gov.** Look for the link that says CLICK HERE TO RENEW; you may have to scroll down the page. You won't be able to renew your license on a phone, you must use another resource.

Click the online renewal option on the homepage to renew online. 6 Continuing Education Hours are due with this renewal, unless you are the age of 65 or older, passed the apprentice or auctioneer exam in 2022 or 2023 OR, you were granted a license by reciprocity in 2022 or 2023. Cannot remember if you already have the 6 hours? Please visit the RENEWAL SEASON section of the website entitled "2023 CE Status". If we do not have it, then **you** are required to enter that information during the online renewal process. In that case, please do not send the Board a hard copy of CE Certificates. Once your renewal has been approved, your license will be mailed to you prior to 09-30-2023. DO NOT DISCARD THE LICENSE YOU HAVE IN YOUR POSSESSION, AS IT IS VALID TO 09-30-2023. Please note that the bonds that are submitted do not reflect an expiration date; therefore, we can't confirm when your bond expires. Please reach out to your insurance agent if you need detailed info. If you receive a receipt from Alabama Interactive, your transaction was processed accordingly, and your receipt will reflect the new expiration date of 09/30/2024. Please do not call the office to see if your renewal was completed, without checking your email box (including your junk/spam box).

The Board encourages renewal BEFORE 09/30/2023, as a late fee will be imposed effective 10/01/2023 and there may be a delay in you receiving your renewed license. You must have your renewed auctioneer license on display; therefore, emailed copies of renewed licenses will not be available, as they are not official.
