RE: Licensing of Companies Engaging in the Online Auction Business

Dear Licensee:

This letter is to inform you that effective January 11, 2025, pursuant to the provisions of ALA. ADMIN. CODE r. 150-X-1-.02, ALA. ADMIN. CODE r. 150-X-1-.02.01 and ALA. CODE §§ 34-4-20 and -28 (1975 as amended), companies engaging in the online auction business in the State of Alabama will be required to obtain a license from the Alabama State Board of Auctioneers and to maintain that license through annual renewals.

The licensure requirement applies to any legal entity which engages in the business of auctioneering, as defined by the Auctioneers License Act and the Board's rules. An auction company <u>exclusively owned and operated</u> by an auctioneer licensed by this Board and in good standing therewith will be exempt from the requirement for a separate auctioneer license; however, auctioneers fitting within this exemption <u>must still complete and file an auction company application with the Board; however, the license fee does not apply.</u> If your online auction company is not exempt, then you must submit the application and licensure fee of \$200.00.

Online auction companies operating without a license after September 30, 2025, may be considered to be in violation of ALA. CODE §34-4-20 (1975 amended) and subject to the applicable penalties and provisions of the Auctioneers License Act.

Enclosed you will find an application for an online auction firm license. Please complete the application and submit it along with the application/license fee of \$200.00 (if applicable) to your company. Depending on the number of owners, please submit one ONLINE AUCTION COMPANY OWNER'S AFFIDAVIT per owner, along with one SIGNED CITIZENSHIP FORM and one FORM OF ID.

# BEFORE YOU FILE YOUR APPLICATION FOR AN ONLINE AUCTION FIRM LICENSE, BE CERTAIN YOU HAVE ALL OF THESE DOCUMENTS COMPLETED OR PROVIDED FOR REVIEW BY THE BOARD'S EXECUTIVE DIRECTOR.

## ANY INCOMPLETE APPLICATIONS WILL BE RETURNED TO YOU.

Please pay additional attention to the following items that are commonly overlooked.

Section 1: Federal Employer's ID Number or Social Security Number; whichever number coincides with your Federal Income Tax Filing.

Section 2: Type of Business – you must complete this section. If your company is anything other than a sole proprietorship (i.e., corporation, partnership, limited liability company, etc.), YOU MUST ATTACH a copy of the company's articles evidencing formation, organization, or incorporation. A sole proprietorship has only one owner.

Section 4: The Board encourages you to read its Rules and Regulations before completing this section, especially Rule 150-X-1-.02 – Application for Auctioneer's License and Rule 150-X-1-.02.01 – Online Auction Firm.

For corporate entities other than sole proprietorships, the qualifying Agent must be a part owner/member of the company and/or have an office/position within the company. As proof thereof, YOU MUST ATTACH a copy of the company's official meeting minutes, resolution or other official action evidencing the qualifying Agent's election to the corporate office or the auctioneer's stated position in the company. All such corporate minutes or resolutions or must be executed on behalf of the company by the appropriate corporate officers; any legal agreement between the company and the qualifying Agent must be signed by the auctioneer, if you have a licensed auctioneer on staff and all corporate owners. Alabama law also requires that you provide proof of citizenship for the qualifying Agent and ALL other company owners.

Please be advised that the Board office cannot provide legal advice regarding the formation of an auction company. If you require assistance, you are advised to consult an attorney or certified public accountant.

Page 4: Escrow Account Form – An escrow account must be established for your online auction company. The company shall create such an account in its own name. In lieu of an escrow account, the company may establish a regular checking account that will be used solely for handling all monies received at auction and disbursed to sellers. This account may not be utilized to pay the company's everyday expenses, such as utilities, cleaning services, or food purchases. If for some reason your company won't be handling funds, please provide a written explanation therefore and submit it with your application.

Any application that is incomplete will be returned to the applicant to the mailing address stated on this application, along with payment submitted.

I understand that every company conducting online auction business in the state of Alabama is required to have a qualifying Agent that shall be designated by an online auction business to bear responsibility for the online auction business to conduct transactions within the guidelines established by the Board of Auctioneers,.
- 2. I hereby certify that I am the designated qualifying Agent who shall transact all business under this license, and I bear all responsibility that this online auction business shall conduct transactions within the guidelines established by the Board of Auctioneers.
- 3. I also certify that I am an officer of the Company. My position with the Company is \_\_\_\_\_\_. I have provided a copy of the Company's official meeting minutes, resolution or other official action evidencing my election to that corporate office or my stated position in the Company.
- 4. I understand that if I am the sole owner and operator of the Company and I am licensed as an Auctioneer in the state of Alabama, I am exempt from the requirement to obtain a separate online auction company license, but I must still submit a completed online auction company application form to the Alabama State Board of Auctioneers for its records. I do not have to submit an application or licensure fee for the online auction company license if I am the sole owner and operator of the Company.
- 5. I understand that as the designated qualifying Agent, I am responsible for all the auction activities conducted on behalf of the Company. I understand that the Company may also have other officers and/or employees who are licensed Auctioneers and who conduct auction business on behalf of the Company. I understand and acknowledge that other than the designated qualifying Agent, only Auctioneers licensed in the state of Alabama may conduct auction business in Alabama on behalf of the Company.
- 6. I understand that only the designated qualifying Agent or a licensed Auctioneer may offer, negotiate, or attempt to negotiate a contract for the sale of any goods or property, including real property, by means of public auction on behalf of the Company. I understand that it is a violation of Alabama law if a qualifying Agent or Auctioneer fails to enter into a written contract with the owner or cosignee of any property to be sold at public auction containing the terms and conditions on which the qualifying Agent or Auctioneer received the property for sale.
- 7. I understand that any Company advertisement for an online auction sale must clearly and conspicuously identify the name and state license number of the online auction firm, together with the name and state license number of any other Auctioneer responsible for the auction if applicable.
- 8. I acknowledge and understand that any and all funds received from auction sales by the Company must be maintained in the Company's escrow account.
- 9. I understand that the Company's owner shall keep account of and disperse any and all monies from the Company's escrow account.
- 10. I understand that I and the Company are both responsible to notify the Alabama State Board of Auctioneers if I am no longer serving as the Company's designated qualifying Agent. I understand that this information must be provided to the Alabama State Board of Auctioneers in writing within thirty (30) days of such change.
- 11. I acknowledge and understand that my or my Company's failure to abide by these requirements and any other applicable laws or Board rules may result in disciplinary action being taken against me or the Company, including, but not limited to, the suspension or revocation of my Online Auction Firm license.

I do not have to submit an application or licensure fee for the online auction company license if I am the sole owner and operator of the Company and a duly licensed Auctioneer in the state of Alabama.
- 4. I understand that the designated qualifying Agent is responsible for all the auction activities conducted on behalf of the Company. I understand that the Company may also have other officers and/or employees who are licensed Auctioneers and conduct auction business on behalf of the Company. I understand and acknowledge that only the designated qualifying Agent or Auctioneers licensed in the state of Alabama may conduct auction business in Alabama on behalf of the Company.
- 5. I understand that only the designated qualifying Agent or a licensed Auctioneer may offer, negotiate, or attempt to negotiate a contract for the sale of any goods or property, including real property, by means of public auction on behalf of the Company. I understand that it is a violation of Alabama law if the designated qualifying Agent or an Auctioneer fails to enter into a written contract with the owner or cosignee of any property to be sold at public auction containing the terms and conditions on which the designated qualifying Agent or Auctioneer received the property for sale.
- 6. I understand that any Company advertisement for an online auction sale must clearly and conspicuously identify the name and state license number of the online auction firm, together with the name and state license number of any other Auctioneer responsible for the auction if applicable.
- 7. I acknowledge and understand that any and all funds received from auction sales by the Company must be maintained in the Company's escrow account.
- 8. I understand that as the Company's owner, I shall keep account of and disperse any and all monies from the Company's escrow account, on terms agreed to by me, as the owner.
- 9. I understand that the Company and the designated qualifying Agent are both responsible to notify the Alabama State Board of Auctioneers if there is a change in the Company's designated qualifying Agent. I understand that this information must be provided to the Alabama State Board of Auctioneers in writing within thirty (30) days of such change.

# **PROOF OF CITIZENSHIP**

Code of Alabama 1975, Section 31-13-29(g) From Act 2012-491

- A driver's license or nondriver's identification card issued by the Alabama Department of Public Safety or the equivalent governmental agency of another state within the United States, provided that the governmental agency of another state within the United States requires proof of lawful presence in the United States as a condition of issuance of the driver's license or nondriver's identification card.
- 2. A birth certification indicating birth in the United States or one of its territories.
- 3. Pertinent pages of a United States valid or expired passport identifying the person and the person's passport number, or the person's United States passport.
- 4. United States naturalization documents on the number of certificate of naturalization.
- 5. Other documents or methods of proof of United States citizenship issued by the federal government pursuant to the Immigration and Nationality Act of 1952, as amended.
- 6. Bureau of Indian Affairs card number, tribal treaty card number, or tribal enrollment number.
- 7. A consular report of birthday abroad of a citizen of the United States of America.
- 8. A certification of citizenship issued by the United States Citizenship and Immigration Services.
- 9. A certification of report of birth issued by the United States Department of State.
- 10. An American Indian card, with KIC classification, issued by the United States Department of Homeland Security.
- 11. Final adoption decree showing the person's name and United States birthplace.
- 12. An official United States military record of service showing the applicant's place of birth in the United States.
- 13. An extract from a United States hospital record of birth created at the time of the person's birth indicating the place of birth in the United States.
- 14. AL-Verify.
- 15. A valid Uniformed Services Privileges and Identification Card.
- 16. Any other form of identification that the Alabama Department of Revenue Authorizes, through administrative rule promulgated pursuant to the Alabama Administrative Procedure Act, to be used to demonstrate or confirm a person's United States citizenship or lawful presence in the United States, provided that the identification requires proof of lawful presence in the United States as a condition of issuance.

## PROOF LAWFUL PRESENCE OF NON-CITIZEN

Code of Alabama 1975, Section 31-13-3-(10)

- 1. A valid, unexpired Alabama driver's license.
- 2. A valid, unexpired Alabama nondriver's identification card.
- 3. A valid tribal enrollment card or other form of tribal identification bearing a photograph or other biometric identifier.
- 4. Any valid United States federal or state government issued identification document bearing a photograph or other biometric identifier, if issued by an entity that requires proof of lawful presence in the United States before issuance.
- 5. A foreign passport with an unexpired United States Visa and a corresponding stamp or notation by the United States Department of Homeland Security indicating the bearer's admission to the United States.
- 6. A foreign passport issued by a visa waiver country with the corresponding entry stamp and unexpired duration of stay annotation or an I-94W form by the United State Department of Homeland Security indicating the bearer's admission to the United States.
